President Whalen welcomed Councillor Al Sizer, as he is attending the meeting as an Alternate from the City of Sudbury. The Agenda was then approved as circulated. 3.0 TIMED PRESENTATION (occurred at 10:09 am)

Chad Evan, Vice President of Corporate Services, delivered greets on behalf of himself and Corrina Moore who will be back to work soon. He was happy to be able to provide and update of the recent activities of the ONTC in 2021. He walked the Board through each of their Business units; Rail Freight (over 700 Miles of track), Motor Coach / BPX, Passenger Rail (Polar Bear Express), and Rail Remanufacturing & Repair. The ONTC was continued to operate all its divisions safely during the Pandemic, continuing to provide a vital link in the North and its expanded bus routes. Chad shared their bus expansion since 2014, which showed they provide services from Ottawa to Winnipeg and Toronto to Moosonee (PBX from Cochrane). He also explained the impact that July's Bus Deregulation may have on their higher populated routes. The relationship with the MTO was reviewed. That the ONTC is working with the Government on the Passenger Rail Business Case, including participating in a track audit.

He shared that Municipalities could help the ONTC by discussing local transportation strategies, to see about synergies. We can continue to advocate the North requires stable, accessible, and integrated transportation to thrive and grow.

5.0 BUSINESS ARIZING FROM THE MINUTES

He also mentioned that he will be reaching out to Minister Rickford's team, regarding out annual grant.

9.0 REGIONAL REPORTS

District of Algoma

L. Watson mentioned that due to the Pandemic, the Algoma District Association had been postponed to the Spring of 2021, possibly virtually. Also, the Algoma District Association is looking for a new Executive Director. Broadband challenges seem to impact every facet of life in the district. But there is light at the end of the tunnel, as several local projects have applied to better connect the region. Several communities have shared their appreciation for FONOM not charging for this years FONOM Conference. He had heard that the FONOM's website had to be updated.

District of Manitoulin

Al MacNevin shared that the island is surrounded by water. He shared that some of the Long Care homes on the Island are starting to receive the COVID19 vaccinations. As well the Island will be getting a freezer that will facilitate the pfizer vaccination. The Arenas are open while respecting Social Distancing. Each community will look at the impacts of the lockdown, and some may end up closing some of the arenas. Al shared that those on the island that are apart of the Starlink Beta test, are all very impressed by the outcomes. He also mentioned that the cost of Starlink was high, but that there is value considering the speed. As well there has been a great deal of cooperation between recently between all the island communities and first nation bands. I

District of Parry Sound

L. Carleton informed the Board that the area had a hectic summer vacation season. One issue that came to life was a Park that had no washroom facilities for campers. Some online short-term rental companies have made changes to their rental policies to address communities' concerns. Lynda mentioned that the many municipal governments are reinforcing to their citizens to follow the COVID rules, addressing the fatigue some are seeing.

District of Cochrane

N. Fortier Levesque updated the Board that Kapuskasing has 6 cases of COVID and the Porcupine Health Unit as a total of 75 active cases. That the region's real estate market is very high, but that the stock is low. She mentioned that the AFMO memberships are up for renewal and encouraged all Municipalities to join. Nicole urged all to stay safe!

City of Timmins

G. Pirie shared that the City has manageable deficit due to the impacts of the Pandemic. That several Companies have be generous with donations to community incentives. Further he mentioned that the Real Estate market has seen nearly a 50% increase. That the mining industry's forecast continues to be positive. Council and the EDC are focusing on the region's Agricultural opportunities.

District of Sudbury

P. Schoppmann advised that the Municipalities in the Sudbury Districts have been quiet, due to COVID. That the new housing and the renovation markets, will have a positive impact on future budgets once MPAC does its reassessment.

District of Nipissing

T. Kelly shared that East Ferris is seeing 25-30 homes being built and the entire Region is seeing a boom in the housing market as well. The Township is planning a new office building and a medical building in the new year.

District of Timiskaming

D. Whalen shared that the Timiskaming Forest Management Plan has been finalized. Also, that most municipalities are focused on COVID!

City of Sault Ste Marie

No update was provided.

City of Greater Sudbury

Al Sizer informed the Board that things are busy in Sudbury, several large projects are under way, that the Real Estate market is experiencing a boom, and the mining sector is on a high. The pandemic has had an impact on the unemployment numbers, with 600 more people looking for work than last year at this time. That the homelessness issue is a concern for agencies and residence, and that there will be public sessions on the issue in late January.

City of North Bay

B. Vrebosch shared with the Board that the North Bay Airport Industrial Park is expanding as it is currently full. He mentioned that the North Bay Real Estate and Home Building market is on a high, greatly influenced by our population increase. As well the City is lobbying for additional federal support for the Jack Garland Airport.

Mac and I sat on a Zoom meeting to discuss our funding with NOHFC and the funding program is suppose to open up in January. It has been suggested by NOHFC that our funding application will be approved and that we may receive three years of funding in one application. I have asked a few questions of revenue Canada people and we should be ok holding these funds as it is how the application process works and not FONOM getting excess revenues.

I had another lengthy Zoom meeting with government relations for Telesat Canada. Thiers is an interesting program but differs in many ways from StarLink. Where Starlink feeds direct to the ground location be it a home or a business or municipal building, Telesat feeds to one ground station and the feed is shared out using existing infrastructure. This is interesting as much of the existing infrastructure is owned by current internet Service providers.

I had the pleasure of presenting the 2020 FONOM Executive Award to Reeve Merrill Bond of Charlton Dack. He was completely unaware and most appreciative of having been recognized by FONOM.

I was able to attend the first unveiling of a Forest Ontario Billboard just outside of our municipality.

I took up every invitation to do year end reviews with the various media. Overall I feel FONOM was well covered in northern media and we were also very well covered in media outside on northern Ontario.
